Your Honor,

I am one of the Defendants in this case. When this case was first filed, I was able to hire a lawyer, and through a demurrer, I was removed from the case. At that time, the Plaintiff's counsel did not offer fraud charges against me.

After they lost, and I was removed, they added completely false charges of fraud against me. This allowed them to bring me back in I am told.

Since they did this, I have tried to find a lawyer to represent me to defend me from these untrue allegations against me. I thought I could find somebody for a price I could afford because after all, I did not own for the company that they are suing and I did not personally guarantee the contract that their client signed. I never committed fraud against the Plaintiff.

I would assume, if they thought I did, they would have sued me in the first place for fraud. Their amendment just threw in this false charge to keep their attack against me.

I don't understand the rules of the court and don't understand why they are suing me.

I have incredible respect for the court, the rule of law, and the importance of what this court stands for. I think it is disrespectful of me to try to represent myself and waste the time of you, your Honor. I will do anything to avoid this from happening.

Your Honor, I should not be in this case. I did not agree with the allegation they are making against me, and there is no way I could ever find justice going against the giant law firm representing myself.

But then I do have hope.

If I do everything in my power and exhaust all my resources, I am confident I can find \$1,000 a month to pay the Plaintiff for the next three months. \$3,000 in total payments. Even this will be a huge burden for me. I will do this to end this not because I did anything wrong but because this law suit has taken a huge toll on my health and mental state. As I try so hard to put my life together this law suit hangs over my head with a cloud of confusion and hurt.
